# MDV / SPA Installation & Operation Instructions

#### **General Information:**

The DEL MDV (Mixing Degas Vessel) allows for a higher concentration of ozone to be used on a spa while preventing virtually all ozone bubbles from returning to the spa, eliminating bubble noise and visibility. The MDV eliminates unused ozone from returning to the spa; eliminates the potential of ozone reacting with pool components such as covers, pillows, fittings, or surfaces; and prevents bubbles from gathering under the cover or inside the plumbing. The MDV system utilizes a GAC destruct cartridge that destroys ozone gas removed by the MDV.

Installation instructions for spas using Recirculation Pumps are on pages 1-2 and for 2-Speed Pumps are on pages 3-4.

**Disclaimer** - This model of MDV is designed to be installed in place of an injector in above ground spas with a recirculation system flowing between 3 and 8 GPM and at pressures below 10 PSI. This unit must be plumbed below the water level in order to work properly. Note that in all instances where ozone injection takes place below water level, check valves are necessary in ozone gas lines. DEL recommends periodic replacement of your check valves to protect your ozonator investment.

If your spa uses a 2-speed pump, rather than a recirculation system, or if your recirculation system flows in excess of 8 GPM, you will have to plumb the MDV in a side stream configuration as detailed in Figure 3. Because spas and plumbing systems can vary greatly, it is impossible for DEL to recommend a specific check valve pressure that will work in all systems. You may need experiment to find the optimal solution for your spa system.

If your plumbing system is above the surface of the water, you will need to use a different model MDV (MDV-10).

#### Installation (recirculation pump):

- 1. Disconnect power to the spa. Drain water if necessary.
- 2. MDV/GAC Mounting:
  - a. Find a suitable location for the MDV under the spa. Allow one or two inches above and several inches below the MDV for plumbing.
  - b. Mount the MDV vertically to a solid surface using (2) Tie Straps, (4) Tie Strap Mounts, and (4) screws as needed.
  - c. When possible, mount the GAC cartridge above the MDV using the stainless steel clip included. Use the flexible tubing provided to connect the top of the MDV to the bottom of the GAC cartridge with the two-loop configuration as shown. If desired, another piece of 1/4" tubing may be connected to the top of the GAC cartridge to redirect any moisture vapor. The tubing loop is designed to cool the water vapor escaping from the MDV to assist the GAC cartridge in destroying any undissolved ozone. Moisture collected in the tubing may have nitric acid and should be disposed of carefully.




Figure 1. Recirculation Pump Installation

- 3. Recirculation Pump Installation (refer to Figure 1):





Figure 2. Injector Insert Installation

  - a. Install the Injector Insert into the inlet fitting of the MDV (Figure 2). Injector Insert will fit past the threads and will snap into place.
  - b. Use appropriate fittings (not provided) to connect the outlet of the recirculation pump to the inlet of the MDV.
  - c. Connect the outlet of the MDV to the return fitting on the spa.


### Installation (2-speed pumps)

- 1. Disconnect power to the spa. Drain water if necessary.




Figure 3. 2-Speed Pump Installation

- 2. 2-Speed Pump (Figure 3)
  - a. Install the Injector Insert into the inlet fitting of the MDV. Injector Insert will fit past the threads and will snap into place.
  - b. Plumb a DELCheck Valve and T's as indicated in Figure 3. Confirm that the water flow direction arrow on the DELCheck Valve matches the water flow direction.
- 3. MCD-50 Installation (Figure 1 or 3)
  - a. Mount and connect the MCD-50 or other DEL Ozone Generator as directed in the ozone generator manual.
  - b. Connect the ozone outlet on the MCD-50 to the Injector Port on the MDV.
  - c. Install the Ozone Check Valve in the tubing between the MCD-50 and MDV. Be sure that the arrow on the Check Valve points to the MDV.

#### Operation

- 1. Allow any PVC glue to dry completely per manufacturer's instructions before running water through MDV.
- 2. Start the spa circulation system. Check for leaks and verify proper operation (Note: Do not run heater until proper function is confirmed.)

### Troubleshooting:

Symptom: No flow through MDV in the wide open position

a. Verify that pump is operating correctly. Remove any kinks or obstructions from water line.

Symptom: No suction from ozone generator

- a. Verify that ozone check valve is facing correct direction.
- b. Verify that Injector Insert is installed.
- c. Remove any kinks or obstructions from ozone line.
- d. Remove return jet fitting and/or replace with larger size.

Symptom: Excess water from top of MDV

a. Verify proper direction of DELCheck valve (2-speed pumps.).

#### Maintenance:

- 1. The MDV is maintenance free. The GAC Cartridge must be replaced every 12 months of operation. A new cartridge can be ordered from your dealer/distributor using DEL part number 9-0556.
- 2. Winterizing, if necessary, can be done by draining water from MDV.
- If necessary, replacement Tie Straps and Tie Strap Mounts can be ordered from your dealer/distributor using DEL part numbers 7-1036 and 7-1037, respectively.
